USAID/Mexico: Senior Police Training Advisor, Mexico

The USAID/Mexico-funded program entitled "Mexico Rule of Law III: Justice and Security Program" seeks to strengthen public transparency, accountability, and oversight, thereby reducing the transnational threats of trafficking of arms, humans, drugs and money laundering that affect both Mexico and the United States. The Senior Police Training Advisor is considered a Key Personnel position under the contract, and will be responsible for implementing Merida Initiative sub-components that include the restructuring, standardization, consolidation and improved training of Mexican law enforcement agencies. This will include training in the new Mexican criminal justice reforms, Human Rights, and fundamental police skills (e.g. report writing, interviewing, investigative procedures, evidence collection/forensics) using educational exchanges, curriculum development, training of trainers, etc.

GRM International: Criminal Justice Advisor

The Criminal Justice Advisor (CJA) based in Yemen, will be contracted by GRM to work within the Ministry of Justice (MoJ) of the Government of Yemen (GoY) and provide advice and guidance on policy direction, legal frameworks, management systems and procedures relating to improving criminal justice in Yemen.

In 2006 the National Assembly of Guinea Bissau approved a National Strategy for Defence and Security Sector Modernization and Reform that outlines seven strategies to reform the police and defense sector as well as the civilian management bodies responsible for implementation of the Security Sector Reform (SSR). Because of its extremely fragile political situation, the country has been placed on the Peace Building Initiative agenda and is thus the recipient of increasing levels of aid to consolidate peace and accelerate human development. Under the overall supervision of the Resident Representative and the guidance of the Minister of Defence, the Strategic Planning Advisor for SSR provides strategic technical direction and supports leadership for SSR.
